

## *No Pink Money for Komen Race for the Cure!*

The Susan G. Komen Foundation Race for the Cure will take place on September 13. There are two major reasons **not** to support this fundraiser:

1. The Komen Foundation refuses to advise women of the abortion-breast cancer link despite many studies confirming that link.
2. The Komen Foundation continues to maintain a national financial relationship with Planned Parenthood, the largest provider of abortion in the United States.

Do not be swayed by the Foundation's defense that grants to Planned Parenthood are not used for abortion. Being a recipient of grants gives a mask of legitimacy to any organization; however, it is impossible to separate Planned Parenthood's abortuaries from services like cervical and breast cancer screening.

The Race for the Cure nationwide is a major source of income to the Komen Foundation. To participate and use that name, all local affiliates, in the past, have given a percentage of their proceeds to the national organization.

Contact our local Race for the Cure and let them know that, not only do they need to acknowledge the link between abortion and breast cancer, but also to alert post-abortive women to be diligent in breast cancer screening.

## **Breast Cancer Survivor Tells the Story of Her Abortion and Subsequent Breast Cancer**

## Human Eggs & ESCR

Through its tax-funded embryonic stem cell research, New York is the first and only state to pay women for their eggs.

Women will be compensated up to \$10,000 for the time, discomfort and expenses associated with supplying their eggs for ESCR.

Soliciting women to donate eggs without financial compensation has failed. Critics fear this payment will lead to the exploitation of women, especially poor women.

**Ethically, critics call \$10,000 an undue inducement; it manipulates women and creates a trafficking in human body parts.**

Fertility clinics currently pay such compensation, but they are not tax-payer funded.

Donors must undergo weeks of hormone injections to stimulate their ovaries to produce eggs; then a painful procedure to extract the eggs.

In rare cases this procedure can cause a dangerous over stimulation of the ovaries and possible long-term risks of hormonal stimulation.

*[We normally do not report on legislation from other states. However, New York's Empire State Stem Cell Board decided to allow financial compensation for egg donations to come from the \$600 million in state funding for ESCR.]*

The Center for Bioethics and Culture recently published the article: "**Woman X – My Story as an Egg Donor.**"

In it, the 29-year-old "Woman X" tells how she needed about \$2500 to complete her graduate degree.

Going online, she found a fertility clinic near her town. She could receive \$2750 if she was selected by a couple, which did happen.

Eight days after her eggs were retrieved, her first medical nightmare began. Fortunately, her medical bills were paid by the clinic and she did receive the best of care.

Five years later she was diagnosed with stage II B breast cancer. (Two doctors mentioned they see more cancer in women who have had fertility treatments. The possible link has not been researched.)

A 35-year-old scientist living on the west coast, Woman X has a 65% chance of living till age 45. Cancer treatments have left her infertile.

**Girls and women need to fully understand not only the physical risks involved in egg donation, but also the very questionable bioethics.**

## Mike Huckabee Dialoguing on Abortion

On a recent late-night comedy show, Mike Huckabee brought up the subject of abortion.

He doesn't think that 'pro-choice' people *like* abortion; rather, they haven't considered the implications.

As 93% of abortions are elective – not for reasons of health – future generations will learn...

"that it is OK to take a human life because [it] represents to us..."

...an interference, or an interruption to our lives either economically or socially."

When Huckabee is old, he doesn't want his kids to say:

"Dad, you are an interference. Coming to see you in the nursing home is really messing up my social life. You are very expensive, Dad."

Huckabee compared equal rights with slavery.

"Does a person have a right to own another person?..."

"Can the mother totally own the child?"

"I just think our culture ought to do everything it can to support and encourage her...

...to make a life decision and to be honest with her and to explain to her: **this is a heartbeat; this is a child.**"
