

“House(s) of Horrors” Five More States

Pennsylvania – On November 19, 2009, Karnamaya Mongar, was given an overdose of Demerol which caused her death in Kermit Gosnell’s abortion mill. While receiving local anesthesia, Mongar’s face turned gray and her breathing slowed. Even so, Kermit Gosnell continued to abort her baby. He could not resuscitate her – nor did he try – as **his defibrillator was broken.**

In 2011, Allentown Medical Services in Allentown was cited for **“preparing to use unsterilized instruments on patients, having drugs...past their expiration dates and for splattering blood on the walls and the floor of a scrub room freezer.”**

In 2012, Pittsburgh’s American Women’s Services and Allentown Medical Services closed because complaints revealed violations **that could not be fixed.**

Virginia – Even with Notice of Inspection, in 2012, **80 regulation violations** were found in abortions mills in Falls Church, Alexandria, Norfolk, Roanoke, and Virginia Beach.

Louisiana – In 2010, the Delta Clinic of Baton Rouge, did not provide women adequate protections for their privacy and **did not monitor** patients receiving sedation **“regarding their cardiac status, respiratory status and level of consciousness during the medical procedure.”**

Florida – In 2011, notorious abortionist, James Scott Pendergraft, owner of five late-term abortion mills, **had his medical license suspended five times for repeated botched abortions.** His medical license is also suspended in Virginia and expired in Maryland and the District of Columbia. [So much for “safety”!]

Texas – Douglas A. Karpen is the “Texas Gosnell.” Four women who previously worked for Karpen, have come forward to give evidence, including photos taken in 2011 on their cell phones, against him. Karpen is said to be guilty of violations, **ranging from sexual harassment to not washing or changing gloves to prevent contamination between abortion patients.**

Most horrendous was **Karpen’s killing of babies born alive during botched abortions by twisting their heads off with his bare hands.** As of June 5, a coalition of 20 Texas lawmakers has requested a full investigation of both of Karpen’s abortion mills in Houston.

Cleveland Kidnapper, Ariel Castro, Being Brought to Trial

On June 7, a Cuyahoga County grand jury returned a **329-count indictment** against Ariel Castro, charging him with the kidnapping and rape of three women. **Two counts** of the indictment are for **aggravated murder in the deaths of two unborn babies.**

Castro not only subjected these women to sexual slavery in his home for years, but also he assaulted them to the point of causing miscarriages. **Michelle Knight was starved and kicked, resulting in her miscarrying five children.** [These women desperately need the healing touch of our God! Let us all “speak” to Him about it. ed]

Ohio does have a Fetal Homicide Law, stating: **“No person shall purposely, and with prior calculation and design, cause the death of another or the unlawful termination of another’s pregnancy.”** According to Samuel Casey, a prolife attorney monitoring the case: “Whether the apparent motive is a commercial one (as in Kermit Gosnell’s case) or sexual abuse (as in Castro’s case), **it should be just as criminal for a health care provider or a sexual deviant to kill a baby born or preborn...**”

## **The President's Corner**

Gun regulation has been a prominent issue in Colorado this year. One of the more consequential questions has been whether the Colorado government has the authority to impose the gun regulations that have passed through the legislative process this year.

This question of authority is also of great importance to the pro-life community. Does government have the authority to legalize the killing of children?

Nazi Germany passed laws making it legal to oppress and kill people of Jewish ancestry. German defendants at the Nuremburg trials attempted to use these laws in their defense.

In the end, though, these German defendants were unsuccessful. The court ruled that the German government had no authority to legalize the dehumanization and killing of Jews.

Similarly, government has no authority to legalize the dehumanization and killing of children. Any defense of abortion based on the fact that it is legal will suffer the same rejection in a future court as the Nazi laws against Jews suffered at Nuremburg.

## **“Death with Dignity”???**

On May 20, Vermont joined Washington, Oregon and Montana, in legalizing physician-assisted suicide, allowing doctors to prescribe lethal medications to patients.

Dr. Paul McHugh, former psychiatrist-in-chief at John Hopkins Hospital, stands in opposition to such laws, writing that physician-assisted suicide supporters are on a deadly mission.

According to McHugh: “It shouldn’t need saying, but the exercises of healing people and killing people are opposed to one another.”

Oncologist, Dr. Kathleen Foley, studies patients with painful cancers and has found that most cancer patients want help with the pain so they can continue to live.

Suicide is mentioned only by those patients with a serious, but treatable, depressive illness or by those who are overwhelmed by the fear of being a burden to their loved ones if they remain alive.

Surely, instead of “death with dignity” we want “life with dignity.” Seeking life, we’re ready to endure much in order to keep it going.

According to Wesley J. Smith, a bioethics attorney, pushing assisted suicide is likely driving up suicides in general. “One suicide begets another, a study in Canada has demonstrated.”

On May 21, in “*Suicide ‘contagion’ effect is real*” the Ottawa Citizen reports:

“That suicide is contagious is a widely held – and controversial – theory. A groundbreaking new study co-authored by University of Ottawa researchers has found that teens who know of a schoolmate who died of suicide are far more likely to think about or attempt suicide than those with no “exposure.”

“[It] supports a theory that has been around for a long time – that suicide contagion **is real**.”

“If suicide is “contagious,” says Smith, then so too is assisted suicide. Indeed, the infectious effect could even be more penetrating throughout general society.”

## **“Crimes Against Pregnant Women”**

### **Colorado HB13-1154**

Signed into law by our governor on June 5, “Crimes Against Pregnant Women” was strongly supported by Planned Parenthood and is **NOT prolife!** The law goes into effect July 1.

Some of the explanation of the law as it was written states: “The bill does not confer the status of “person” upon a human embryo, fetus, or unborn child at any stage of development prior to life birth.”

Also stated in the explanation is: “The bill repeals the criminal abortion statutes.” Hence, instead of protecting pre-born babies, **all protective laws in Colorado are now repealed.**

Voting for this bill was three of our local legislators: Mark Waller, Lois Landgraf, and Bob Gardner; heretofore thought to be prolife.

## **Why Notify Parents?**

Recently, this story broke in the state of Washington. Last August, a 12-year-old girl was raped and impregnated by a 31-year-old man who took her to Planned Parenthood, forcing her to have an abortion.
